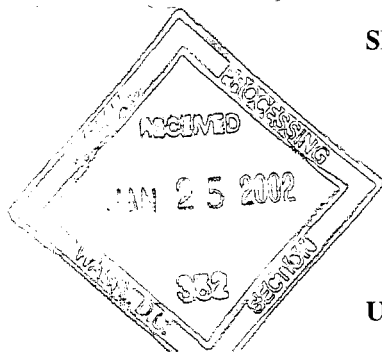

* The Issuer will pay all organization costs, to be amortized over 20 calendar quarter, as well as its operational expenses, including legal, accounting, auditing and tax preparation fees and expenses, and extraordinary expenses. The Issuer will also pay K2/D&S Management Co., L.L.C., the Issuer's management company, an annual management fee of 1.25% of the Issuer's net assets, such fee to be paid in quarterly installments. If the General Partner permits investments less than the \$1,000,000 minimum, the management company may charge an annual management fee of up to 1.5%. The General Partner may waive the management fee. The General Partner will be allocated a profit allocation of 10% of the amount by which any net profit allocated to each limited partner's capital account exceeds 7% (adjusted for capital contributions and withdrawals) during any calendar year. None of such fees or expenses can be quantified at present.
