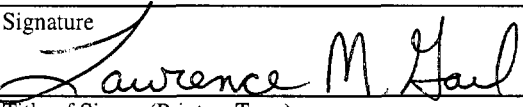

Footnote to Part C - Question 5

Salaries and Fees

Issuer will pay to Quellos Capital Management, L.P. as its investment manager, a quarterly advisory fee which will vary depending upon (i) whether the applicable shares are treated as "standard" or "committed" and (ii) Issuer's performance relative to a predetermined "Quarterly Base Return." If Issuer's actual return is equal to or less than the Quarterly Base Return, the advisory fee for the applicable quarter is equal to (i) one quarter of 1.00% of the net asset value of Issuer with respect to standard shares or (ii) one quarter of 0.75% of the net asset value of Issuer with respect to committed shares. If Issuer's actual return is greater than the Quarterly Base Return, the advisory fee for the applicable quarter will be increased by (i) 15.625% of the excess, but in no event greater than a total of one quarter of 3.50% with respect to standard shares or (ii) 12.50% of the excess, but in no event greater than a total of one quarter of 2.75% with respect to committed shares.
