

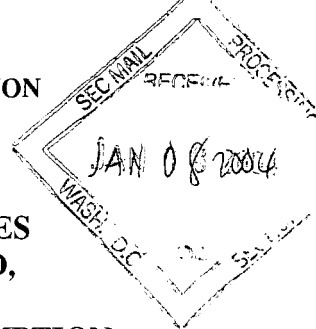

In addition, each month the general partner of the Issuer is allocated 20% of the amount (if any) by which the profits allocated to the limited partners exceeds the greater of (i) the Limited Partner's capital account as of the beginning of such month and (ii) his, her or its "loss carryforward account." All fees have been waived for the initial investors all of whom are employed by the Issuer's investment adviser.
