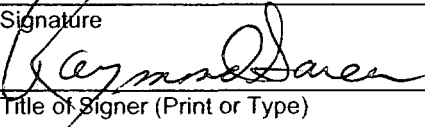

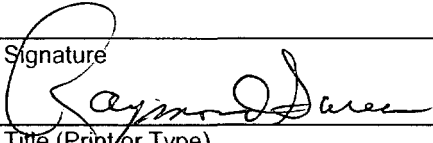

EXHIBIT A

The Fund was formed to pool investment funds of investors for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic or foreign, of all kinds and descriptions, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, monetary instruments and cash and cash equivalents, all as determined by the Investment Manager in its sole discretion. The Company is offering shares of stock on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of shares which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
