Addendum

The amount already sold does not include \$652,000 paid in by the directors for their membership units. There are 21 directors. 18 directors paid in full (\$35,000 for each director), one director paid in partially, and two newly invited directors have not paid yet. Payments by non-director investors are being held in a separated holding account. Seoul Country Club was organized to purchase and operate Bergen Hills Country Club, located in New Jersey. If the purchase is not consummated for any reason, non-director members will be fully refunded for their payments, all expenses incurred will be born by the directors equally and Seoul Country Club LLC will be dissolved.

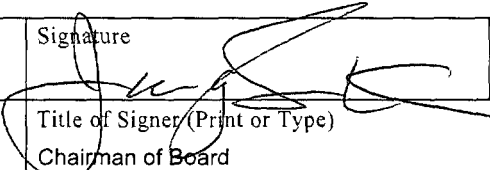

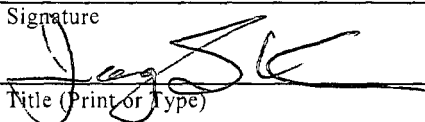
