EXHIBIT A

Form 4 Diversification Fund, LP ("Partnership") is a limited partnership organized for investing in publicly traded common and preferred stocks, derivatives (including swaps, forward contracts and structured instruments), monetary instruments, cash and cash equivalents. The Partnership's minimum investment amount is \$250,000, although the General Partner has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the general partner of the Partnership, Open Door Partners, LLC. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
