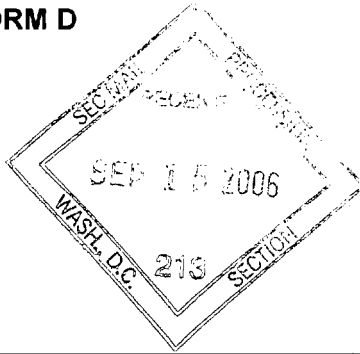
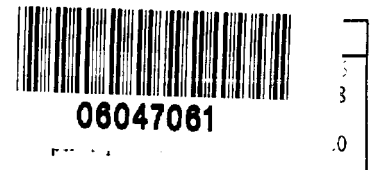

The Class B Units are subject to certain restrictions contained in the Agreement and InnoWare received no consideration for the Class B Units.

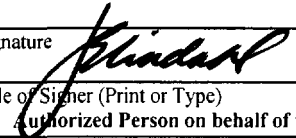

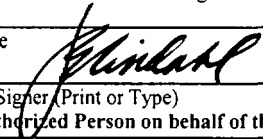
