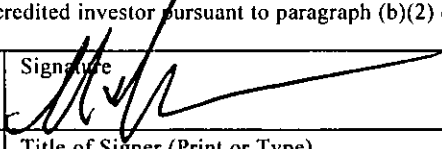

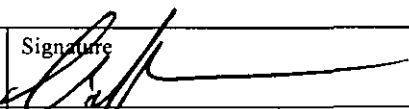

Section C – 1

Convertible Securities (Including Warrants)

The Company is offering 12% convertible subordinated notes due 2011 ("Notes"). Holders of the Notes may convert their Notes to shares of the Company's common stock in certain circumstances.

The conversion rate will be 16.13 shares of common stock for each \$1,000 principal amount of Notes converted.
