**JOINT MOTION OF DIVISION OF ENFORCEMENT
AND RESPONDENT TO SET BRIEFING SCHEDULE**

The Division of Enforcement (“Division”) and Respondent I. Joseph Massoud (“Respondent”) hereby request with this joint filing that the Commission set a briefing schedule in this matter as set forth below.

Respondent Massoud on August 5, 2025, submitted a letter to the four members of the Commission requesting relief from a bar from association issued by the Commission on January 11, 2013. On August 7, 2025, the letter was docketed in this matter as “Letter to the Commission Dated 8-5-2025 re Request to Vacate Associational Bar.”

Since the submission of the letter counsel for the Division and for Respondent Massoud have conferred and stipulate that a) the August 5, 2025, letter was intended as, and should be docketed and treated as, a motion by Respondent Massoud to vacate the January 11, 2013, associational bar, and b) the Division of Enforcement has been served with, and has accepted service of, Respondent’s motion as of the docketing date (August 7, 2025).
