DIVISION OF ENFORCEMENT'S STATUS REPORT
AS TO SERVICE OF ORDER INSTITUTING ADMINISTRATIVE PROCEEDINGS

The Division of Enforcement (“Division”), by counsel, provides the following status report as to the status of service of process on the Respondent, BorrowMoney.com, Inc. (“Respondent” or “BorrowMoney”), and states the following:

1. On December 12, 2025, the Commission issued its Order Instituting Proceedings and Notice of Hearing Pursuant to Section 12(j) of the Securities Exchange Act of 1934 (“OIP”) (Exchange Act. Rel. No. 104373).
2. On December 15, 2025, the Office of the Secretary mailed, via certified USPS mail, the OIP to the last publicly filed address of BorrowMoney as found on EDGAR.¹
3. On December 29, 2025, the attempted delivery of the OIP was returned to the Secretary’s Office as undeliverable. The envelope also contained a yellow sticker indicating a forwarding address in New Jersey, but with a notation that the forwarding time had expired.

¹The address filed on EDGAR did not have an apartment number, but based on prior information, the staff provided the Secretary’s Office the apartment number to add to the service address.

4. In abundance of caution, the Division is now going to attempt to serve the OIP on BorrowMoney at the New Jersey address contained on the yellow sticker on the envelope returned to the Secretary via USPS Priority Mail Express.

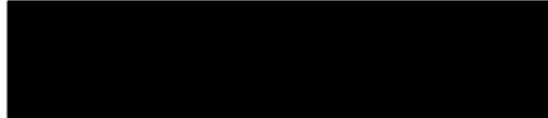
