**DECLARATION OF GINA JOYCE**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the Respondent in the captioned proceedings pursuant to Rule 141(a)(3).

2. Among other means, Securities and Exchange Commission (“Commission”) Rule of Practice 141(a)(2)(ii) permits service on a corporation or entity by delivering a copy of an Order Instituting Administrative Proceedings (“OIP”) to an agent authorized by appointment or law to receive such service or, in the case of an issuer with a class of securities registered with the Commission, by sending the OIP via U.S. Postal Service certified, registered, or express mail and obtaining a confirmation of attempted delivery on the most recent address shown on the entity’s most recent filing with the Commission. Further, the OIP in this matter authorizes service of the OIP “by any means permitted by

the Commission's Rules of Practice." Therefore, the Division asked the Commission's Office of the Secretary ("OS") to first attempt service on the Respondent via Certified Mail.

3. The OS provided me with the Certified Mail tracking number for the copy of the Order Instituting Proceedings ("OIP")<sup>1</sup> that was mailed by the OS to the Respondent in these proceedings. I input the tracking number into the package tracking system of the U.S. Postal Service ("USPS") on its Internet website located at [www.usps.com](http://www.usps.com), and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the Respondent. A true copy of the tracking confirmation for the Respondent on which Certified Mail service was attempted is attached as Exhibit 1, hereto.

4. The OS mailed the OIP to Respondent MJ Holdings, Inc., CIK 1456857 ("MJNE"), via Certified Mail, Tracking No. 7017 1450 0002 3709 3452, to the address shown on its most recent EDGAR filing at 2043 Joy View Lane, Henderson, NV 89012. This address is taken from MJNE's last filing with the Commission, which was a Form 12b-25 (a/k/a NT 10-K) filed with the Commission on April 8, 2024. (A true copy of the face page of the Form 12b-25 is attached hereto as Exh. 2, and a true copy of its last 8-K filed with the Commission on March 27, 2024 is attached hereto as Exh. 3). The USPS tracking system confirms that delivery of the OIP package was attempted on September 13, 2025, but the addressee was unknown. *See* Exh. 1.

5. Exhibit 3 shows that MJNE is a Nevada corporation. A search of the website of the Nevada Secretary of State reveals that the name and address of MJNE's registered

agent are Christopher Doubek, 2043 Joy View Lane, Henderson, NV 89012. A true copy of the printout of MJNE's corporate status pages from that website is attached hereto as Exh. 4. Although the address of the registered agent is the same address that MJNE has on file with the Commission, the Division, nevertheless, provided MJNE's registered agent's address to the OS and requested that the OS attempt service on MJNE's registered agent via certified mail. The OS provided me with the certified mail tracking number for the OIP package mailed to MJNE's registered agent, Tracking Number 7017 1450 0002 3709 3445. My search of the USPS tracking system confirms that delivery of the OIP package was attempted on September 13, 2025, but the addressee was unknown. A true copy of the tracking confirmation for Respondent's registered agent is attached hereto as Exhibit 5.

I declare under penalty of perjury that the foregoing is true and correct.
