The Securities and Exchange Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934, of trading in the securities of Charming Medical Limited (“MCTA”) (CIK No. 0002035992), a holding company incorporated in the British Virgin Islands and headquartered in Hong Kong, at 4:00 AM ET on November 12, 2025, and terminating at 11:59 PM ET on November 25, 2025.

The Commission temporarily suspended trading in the securities of MCTA because of potential manipulation in the securities of MCTA effectuated through recommendations made to investors by unknown persons via social media to purchase, hold, and/or sell the securities of MCTA and to send screenshots documenting their transaction. These recommendations appear to be designed to artificially inflate the price and volume of the securities of MCTA. The order was entered pursuant to Section 12(k) of the Exchange Act.

The Commission cautions broker-dealers, shareholders, and prospective purchasers that they should carefully consider the foregoing information along with all other currently available information and any information subsequently issued by the company.
